## Trophy Club Outfitter Rules and Regulations

### Hunting

1. No animal smaller than a 8pt \*(125)\* **140** minimum on Gun Hunts (STRICTLY ENFORCED)
2. 15" inside spread on main beams \*(125)\* **140** minimum on Gun Hunts (STRICTLY ENFORCED)
3. Rule #1 and #2 are the most important \$1,500.00 fine or trophy fee if buck is less than the minimum restrictions above
4. Button bucks are \$500.00 fine or trophy fee. BE POSITIVE before shooting doe's!!!. This has happened !!
5. Coyotes are always fair game. We encourage the harvest of coyotes.
6. Easter Turkeys are legal during season. Make arrangements with Neil if interested. Requires an additional tag.
7. Make your best effort for a quality shot on the animal and with in your own abilities. Do not shoot farther than you practice.
8. When you arrow an animal or connect with a muzzleloader shot call your guide. Stay in stand and wait for assistance from guide.
9. You and your guide will recover the deer. The hunter may bring only one other person with, if desired. Once we find the deer, others can be called in for pictures.
10. For ARCHERY hunts if blood is drawn and deer cannot be located... the hunters and the guide will continue the search for 24 hrs. from the time the shot was placed. If we determine after 24 hrs, that we are not able to retrieve it, the hunter may pay a "wound fee" of \$300.00 to continue hunt. Draw blood the 2nd time... this is your deer.. find it... NOTE: this is only on Bucks.
11. Muzzleloader hunts differ from rule #10. If you draw blood, the hunters and the guide will continue the search for 24 hrs. from the time the shot was placed. If we determine after 24 hrs, that we are not able to retrieve it, the hunter may pay a "wound Fee" of \$750.00 to continue hunting. Draw blood the 2nd time... Your hunt is over... Make a good shots!!
12. Safety harness/belts are to be worn on every stand.
13. All waivers must be signed before hunting.
14. Hunt must be paid in full before hunting.
15. Climbing stands are allowed and encouraged. Make arrangements with guides

whenever you are ready to adjust your position.

16. Follow the "golden rule" in the treatment of all others in camp.

17. Do not disturb the farm operations. Stay out of the way of the farmers. If around, we hunt around their schedule.

18. Keep personal things locked up. Vehicles need to be parked behind the south side of the lodge. Do not block the driveway.

**LODGE**

1. All rooms have their own individual thermostats for heat.
2. Respect those who are resting.
3. Always break pool balls away from the glass (French) doors.
4. Be respectful of others utilizing bathrooms and shower, as these are tight quarters.
5. The West Barn across the driveway has a toilet and utility sink. Ask the guide to unlock if additional usage/privacy is needed.

## WAIVER AND RELEASE AGREEMENT

Please read carefully before signing

This is a release of liability and waver of certain legal rights

In consideration for my being permitted to participate i the activities of HUNTING AND RELATER ACTIVITIES, I agree to the following waiver and release.

I acknowledge that HUNTING AND RELATED ACTIVITIES THERETO has inherent risk, hazards, and dangers for anyone that cannot be eliminated, particularly in a wilderness environment. I UNDERSTAND AND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATIONS.

1. The risk of handling firearms and being near others that have firearms in their possessions.
2. The risk of injury from ammunition and shot from other guns.
3. Walking in rugged country, including encounters with wildlife, animals and insects.
4. Inclement weather conditions.
5. The risk of injury from riding on all terrains vehicle (ATV) or any vehicle used off the paved road.
6. The risk of injury from the use of tree stands.

I understand the risk, hazards, and dangers as described above and have had the oppportunity to discuss them with REPRESENTATIVES OF THOPY CLUB OUTFITTERS, INC. I understand that these activities may require good physical conditioning and a degree of skills and knowledge. I believe I have that good physical conditioning and the degree of skills and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and elect to participate in spite of the risk. I AM VOLUNTARILY USING THE SERVICE OF REPRESENTATIVES OF TROPHY CLUB OUTFITTERS, INC. WITH FULL KNOWLEDGE OF THE INHERENT RISK, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEP ANY AND ALL RICK OF INJURY, PARALYSIS, OR DEATH.

## Terms and Conditions

All hunts will consist of hunting from existing stands or if special arrangements have been made for a hunter to bring their own climbing stand, and transportation to meat processor.

Hunts include lodging and meals only. Hunts do not include license fees, alcohol, meat processing, taxidermy and transportation to and from airport (unless specified). License fees and bag limits are subject to change by commission without notice and the hunter accepts and understands this. No representing is made that a given hunt is high quality, high demand or standard. Due to printing updates or lack of or changes made by Indiana Department of Game and Fish, some advertising statements may or may not remain accurate and the hunter accepts and understands this.

Deposits are non-refundable. Payment in full for hunt will be paid 30 days prior to arrival or day of arrival before any hunting or scouting can be done. Trophy Club Outfitters, Inc. reserves the right to cancel the hunter and/or release this contract to another outfitter.

Hunting is strenuous, physical exercise requiring stamina and good conditioning. The weather in Indiana can vary greatly over a short period of time and extreme conditions of adverse weather may be encountered. The hunter recognizes these facts and represents that he/she is in good health and good physical condition so that he/she can participate in the hunt; unless he/she is handicapped and participating in the special handicap hunts.

Hunting is an activity requiring the use of weapons such as firearms and bows, which can produce injury. It requires hazardous activities in the wilderness. The hunter recognizes and accepts all risks which can arise during hunting. The hunter holds harmless, forgives, releases and waives any claims which he/she may have against Trophy Club Outfitters, Inc.

Trophy Club Outfitters, Inc. will use its best efforts to provide quality guiding and outfitting services to the best of its abilities. Trophy Club Outfitters, Inc. cannot and does not guarantee good weather or a successful kill of game, not that the hunter will kill a trophy animal, and the hunter accepts these terms. Neither weather nor the results of the hunt are guaranteed.

From time to time our modern society, disputes arise and the hunter agrees that Indiana law shall govern this contract and the legal obligations of Trophy Club Outfitters, Inc. The hunter also agrees that the District Court of Putnam County, Indiana shall be the exclusive and sole venue for all suits which may arise out of any disputes concerning this contract and the services provided by Trophy Club Outfitters, Inc. In the event suit is filed prevailing party shall be entitled to reimbursement of the attorneys fees.

The hunter agrees that he/she will abide by all Federal State and local laws at all times and will not engage in any conduct which may subject Trophy Club Outfitters, Inc., its employees, guides or customers to investigation or prosecution. By signing you agree to these terms and conditions.
